WEST Virginia Tri-Super force-out consolation rule: (Wheeling Island)

8.15.16. If the Tri-Superfecta carryover is designated for distribution on a specified date and performance, the following precedence will be followed in determining winning tickets for the second-half of the Tri-Superfecta after completion of the first-half of the Tri-Superfecta:

8.15.16.1. As a single price pool to those whose combination finished in correct sequence as the first four betting interests; but if there are no such wagers, then

8.15.16.2. As a single price pool to those whose combination included, in correct sequence, the first three betting interests; but if there are no such wagers, then

8.15.16.3. As a single price pool to those whose combination included, in correct sequence, the first two betting interests; but if there are no such wagers, then

8.15.16.4. As a single price pool to those whose combination included, in correct sequence, the first-place betting interest only; but if there are no such wagers, then

8.15.16.5. As a single price pool to holders of valid exchange tickets, then

8.15.16.6. As a single price pool to holders of outstanding first-half winning tickets.

Florida Tri-Super force-out consolation rule: (Daytona Beach Kennel Club)

(17) When a forced or early payout occurs, the jackpot shall be awarded in the following precedence:

(a) To those who correctly selected the Trifecta or Superfecta in the second half contest, if the winning combination is not covered,

(b) To all holders of exchange tickets from the first half contest.

(c) In the event the second half of the contest is canceled, declared null, or no contest, the jackpot may be distributed in one of the following methods:

1. To holders of tickets as reflected in paragraph (b) above,

Arkansas Tri-Super force-out consolation rule: (Southland Park)

In the event there is no Tri-Super exchange ticket accurately selecting the officially declared first four (4) finishers of the second Tri-Super race, in exact order, payoffs shall be made on Tri-Super tickets selecting the following order of priority:

1) The first three greyhounds, in exact order (for example 1-2-3-All)

2) The first two greyhounds, in exact order (for example 1-2-All-All)

3) The runner to finish first (for example 1-All-All-All)

4) Failure to select the runner to finish first will cause the pool to be divided equally between the holders of a second half exchange ticket.
